Mechanism of redressal of students' ragging grievances

The Institution has a transparent mechanism for timely redressal of students' grievances in case of ragging cases. The students submit their grievances either directly to the Principal (Chairman of antiragging committee) or to the Secretary or any other members of antiragging committee (ARC). Students may drop their grievances in the complaint and suggestion boxes also, placed in all academic blocks of the institution which are regularly opened. If the member received the complaint he/she then brings the grievances to the notice of Secretary/Chairman of the ARC, where the grievances are addressed by a committee which includes the Principal, secretary and other committee members.

In compliance with the directives of the Hon'ble Supreme Court of India and the UGC regulations on curbing the menance of ragging in Higher Educational institutions, 2009, the College has formed the Anti-Ragging Committee, Cell and squad for overseeing the implementation of the provisions of the verdict. Antiragging squad regularly raid the college premises and surrounding premises to keep watch, whether any ragging sort of activity occurring in the premises. Affidavits are taken from the students signed with parents at the time of admission to the program that he/she will not involve in any sort of ragging cases during his academic career.

Composition of the Anti Ragging Committee

Chairperson: Principal

Secretary: Professor/Associate Professor

Members: Police Representative, Local Media Representative, NGO representative, Parents representative, College Faculty Members, Students representatives and non Teaching Staff Members.

Following are the steps to be taken in case anyone is found to commit, participate in abets or instigate ragging within or outside the college campus:

- I. The student shall be suspended, expelled or rusticated from the institution.
- II. The punishment may also include cancellation of admission, suspension from attending classes, withholding/withdrawing fellowship/ scholarship and other financial benefits and withholding of results.
- III. If the persons committing or abetting the crime of ragging are not identified, the institution may resort to collective punishment as a deterrent to ensure community pressure

- IV. The final decision shall be taken by the anti ragging committee of the College.
- V. Rustication from the institution for period ranging from 1 to 4 semesters.
- VI. Expulsion from the institution and consequent debarring from admission to any other institution.

VII. The students as well as their parents, at the time of admission to the Institute, will be required to furnish an undertaking that the students will not indulge in any form of ragging.
